# Kootenay Lake District Parents' Advisory Council Meeting September 19, 2024 6:00pm-8:00pm (PST) Video Conferencing via Zoom **Minutes**

5) Superintendent's Report plus Guest Assistant Superintendent Deanna Holitzki

- Beginning 4th year in the district nice to recognize faces
- Lots of excitement with back to school
- General ministry updates Code of Conduct with cell phones and personal digital devices are specific to each school and may be different for different grades, legislation introduced to prevent disruptive events near schools, family engagement nights to continue this year
- Introduction to SD8 website navigate to the "Students & Families" tab for other information including DPAC meetings and Family Engagement Sessions. Recordings may also available. Upcoming on September 26 - Digital Trends.
- School Planning Day is tomorrow (September 20). School Learning Plans are also available on the SD8 website under the "Schools" tab, select your school of choice, and go to the "About" tab.
- September 30 is National Day of Truth and Reconciliation so schools will also be closed.
- Assistant Superintendent Holitzki on Food Equity Programs
  - All students have access to the BC Fruit & Vegetable Nutrition Program
  - Province invested funding over three years for school equity

- Feeding Futures Funding in the district can be used for breakfast, snacks and/or lunch for vulnerable students
- Guiding documents include the Canada Food Guide and BC Grown Foods (where possible use BC/local foods)
- Since Spring of 2023 have a school food advisor, enhanced fruit & vegetable program in rural schools, doubled the number of students regularly provided a meal in school (823/day)
- Have made infrastructure upgrades at JVH, KRSS, Redfish, ARES and Salmo
- Purchased over \$40k of equipment throughout the district for all schools
- Food advisor working with teachers to increase food literacy in classrooms

- Valuable role of parents & PACs will continue to be guided by the school principal
- Final tweaks on a New Fundraising Guide for 2024/2025 then will be released

### 6) Treasurer's Report by Natalia Nazaroff

This summer it came to the executives attention that there were some discrepancies in our accounts, dating back to 2020. It can be made known that the treasurer submitted her resignation on August 23 2024.

As a result of this discovery, the remaining executive is working hard to reconcile the books. To date we have found an approximate \$15,000 discrepancy in our accounts. The treasurer's reports that were given were not accurate accounts of what our bank balances were. We didn't know we hadn't received our Gaming Grants for 3 years. This is an additional \$7,500 in lost revenue due to lack of completion of our fiscal year end requirements for BC Gaming. Our executive has spent countless hours working on our Gaming reports in order to hopefully qualify for a late application for this upcoming school year. Unfortunately, we are unable to provide the membership much more information at this time due to the Police investigation as well as the Bank investigation. We will make updates to our members as information becomes available.

Today the balance in our Gaming account is \$62.73. And our balance in our chequing is \$2,143.06. We still have \$2,168.13 outstanding for the BCCPAC AGM and for the Gordon Neufeld conference. We do not have enough money in our accounts to pay these expenses therefore, this debt will be waiting for reimbursement until we have enough money in order to be reimbursed. Unfortunately this means we do not have enough money in our accounts to pay for BCCPAC memberships for all our schools this year as we had previously motioned. We will still encourage your PAC's to purchase their \$100 membership out of their Gaming accounts. We also will not be able to run any parent education nights that have a cost associated with them until this matter is resolved. We still have some other expenses to approve at tonight's meeting such as the DPAC'S BCCPAC membership.

We thank you all for your understanding and giving us the time we need to look into this matter. Our executive will continue to spend many hours working on this and on creating strong fiscal policies.

- Fiscal policy ideas to consider
  - Show who each cheque is written to
  - Hire an independent bookkeeper
  - Verify that gaming grants were applied for
  - Show bank statements in meetings with account numbers redacted
  - Ensure system to change over signers and hand over documents
  - Signers can go into the bank and verify account balances
  - Banks are not chequing the signatures, such as if the two signatures are correct or if there are two signatures and the bank policies say they do not do this
